1. Background

Reall is a UK-based international development organisation that is building an affordable homes movement that will improve the life chances of 100 million people in urban Africa and Asia by 2030. Reall's strategy is to get affordable homes built at scale by targeting investments, generating ideas, and championing evidence. This accelerates the flow of capital and the availability of end-user finance, leading to catalytic commercial, economic, and socially sustainable change. Reall specifically targets the 40th percentile and below of the income pyramid in each location.

Reall has long-term core financing from the Swedish International Development Co-operation Agency (SIDA), but we need to expand our funding base to deliver on our ambitious corporate strategy and fulfil our impact potential. Reall operates a 'build' and 'broker' model and requires a blend of grant and debt finance.

2. Purpose of the Consultancy

The purpose of this consultancy is for Reall to create a database of bid writers that we can call on to lead and deliver on specific calls for proposals. The consultants will produce professionally written proposal and pitch content that superbly articulates Reall's value proposition, understanding the nuances of our social justice, inclusivity, ethical, and innovation considerations. The consultant will be typically engaged to help develop the value proposition and articulate the win themes and solution narrative and the consultant will be responsible for deciphering any RFPs and formulating a proposal with support from key members within Reall. 3. Experience and Qualifications

The consultant will have proven skills in writing funding proposals within a complex business environment and be experienced in leading proposal writing processes, participating in key review meetings and working towards a final document that is submission ready. Excellent written English language skills are essential for this role.

Experience of writing proposals within a development context in emerging markets across Africa and Asia is essential and knowledge of the affordable housing sector and/or climate-smart technologies is desirable but not essential.

4. Methodology

For each project, the consultant will start with discussions with Reall staff in a workshop to provide the consultant with all necessary information after which the consultant will
